# UNFINISHED BUSINESS

#### Mayor Rose

He noted Russell Heights Reconstruction is now completed with second layer of Asphalt and Main Street reconstruction is anticipated to be completed before the tourism season starts with the final layer of asphalt in 2026.

Discussed improving signage to direct tourists travelling from Port Au Port Peninsula to detour to Main Street to boost local commerce instead of travelling via Route 460 Hansen Highway to TCH.

Started line painting, including the addition of bike lanes, are still being completed.

The Stephenville Theatre Festival is opening for its 47<sup>th</sup> Season with a strong lineup, including the musical " All Shook Up" featuring songs by Elvis Presley and it was noted that Elvis Presley visited Stephenville, and documentation of his visit was sent to the Museum in Graceland as noted by Councillor Hynes.

He addressed public comments made by Mr. Bob Byrnes regarding the towns development and support, and suggested the business community consider replacing Mr. Byrnes as their spokesperson for an individual with diplomacy and positive focus for the town.

#### Councillor O'Brien

He presented a suggestion from a resident, noting that since the airport is privately owned the town should lobby the provincial government to establish a small landing strip to accommodate air ambulances.

Councillor Aylward

She made comments relating to the ownership of the airport, noting that she believed the airport belongs to the people of Stephenville, not a board or private entity. She suggested an investigation should be conducted to clarify ownership, emphasizing that the airport is a crucial public asset and should not have been sold and she would support a citizen's rally. She sent condolences to the family of late Clara Samms, who was 104.5 years old.

#### **Deputy Mayor Fowlow**

She emphasized the importance of critical thinking when evaluating reports or news. Noting the research can be presented to support different viewpoints depending on the desired outcome. She reminded everyone that stories can be created to reflect the creator's perspective, and council not addressing comments doesn't mean agreement or its right. She encouraged people to consider the source and context of the information before forming opinions, and she highlighted there are always multiple sides to a story to consider.

She addressed residents' requests for speed bumps, stating that the council had discussions with the RCMP and we are looking to mitigate the larger issue of speeding in our community as opposed to just specific streets. Mayor Rose stated the the future roundabout on Minnesota Drive will reduce the traffic within the Georgia Drive areas.

# **NEW BUSINESS**

#### **Councillor Hynes**

He mentioned that tourism groups have been arriving. Last week, a group of sixty tourists from United States, Nova Scotia, British Columbia, and Saskatchewan visited the area.

Councillor O'Brien also noted a tour bus with 40 tourists, including international visitors, was a part of a themed tour called "chasing quilts"
